3. Freight On Board (FOB) - Island Garden City of Samal;
4. The following documents must be attached in submitting this quotation: a) Valid Business Permit, b) Valid DTI Registration Certificate, c) Valid PhilGEPs Registration Certificate, d) Latest Business and Income Tax Return, and e) License to Operate;
5. Evaluation of Quotations. Quotations shall be compared and evaluated on the basis of the following criteria: a) Price Quotation, b) Compliance with Items & Description Requirements with prices and quotations not exceeding the ABC per item, c) Completeness of documents as required in item c, and d) In case of tie, method to be used to break the tie is by "draw lots";
