The **LOCAL GOVERNMENT UNIT OF ISLAND GARDEN CITY OF SAMAL** (LGU-IGaCoS) now invites bids For the Preparation of ETRACS System Equipment charged to Revenue Generation/Mobilization Program *under PR No. 2018-10-4122* Delivery of the Goods is required **TEN CALENDAR DAYS (10CD) upon receipt of Notice to Proceed** Bidders should have completed, within **TEN (10) YEARS** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from **BAC SECRETARIAT, BAC OFFICE, CITY HALL COMPOUND, PENAPLATA, IGACOS** and inspect the Bidding Documents at the address given below during *from Office hours*

A complete set of Bidding Documents may be acquired by interested Bidders on **March 5, 2019** from the address below *and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand Pesos Only. (Php 1,000.00).*

The *LGU-IGACOS thru its Bids and Awards Committee* will hold a Pre-Bid Conference¹ on *March 13, 2019, 1:00pm* at *BAC CONFERENCE ROOM, BAC Office, City Hall Compound Penaplata, IGACOS* which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before *March 25, 2019, on or before 12:00 noon*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *March 25, 2019, 1:00pm* at *BAC CONFERENCE ROOM, BAC Office, City Hall Compound Penaplata, IGACOS*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *LGU-IGACOS* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
