Invitation to Bid for *Completion of Dormitory Bldg. Inside Kaputian Beach Park/Development of Beach at Poblacion Kaputian District, IGaCoS under PR No. 2022-06-3754*

1. The *Local Government Unit of the Island Garden City of Samal (LGU-IGaCoS)* through the *General Funds CY2022* intends to apply the sum of *Four Million Nine Hundred Sixteen Thousand Six Hundred Forty Eight Pesos and Thirty Seven Centavos (Php4,916,648.37)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Completion of Dormitory Bldg. Inside Kaputian Beach Park/Development of Beach at Poblacion Kaputian District, IGaCoS under PR No. 2022-06-3754*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU-IGaCoS* now invites bids for the above Procurement Project. Completion of the Works is required *One Hundred Twenty (120) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *LGU-IGaCoS BAC Secretariat* and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be acquired by interested bidders on *July 28, 2022* from given address and website/s below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00)*.
6. The *LGU-IGaCoS* will hold a Pre-Bid Conference¹ on *August 4, 2022 1 o'clock in the afternoon* at *BAC Conference Room, City Hall, Penaplata, IGaCoS* which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before *12 noon of August 16, 2022*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on *August 16, 2022 1 o'clock in the afternoon* at BAC Conference Room, City Hall, Peñaplata, IGaCoS. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *LGU-IGaCoS* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
