## INVITATION TO BID FOR

### ***EXPANSION OF ELECTRIFICATION PROJECT FROM PUROK 6 TO PUROK 4 AT TAMBO, BABAK DIST IGACOS. UNDER PR NO. 2022-03-2473***

The *Local Government Unit of the Island Garden City of Samal*, through the ***General Fund 2022*** intends to apply the sum of ***Eight Hundred Forty-Five Thousand Three Hundred and Five Pesos (₱845,305.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***EXPANSION OF ELECTRIFICATION PROJECT FROM PUROK 6 TO PUROK 4 AT TAMBO, BABAK DIST IGACOS. UNDER PR NO. 2022-03-2473***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Local Government Unit of the Island Garden City of Samal* now invites bids for ***EXPANSION OF ELECTRIFICATION PROJECT FROM PUROK 6 TO PUROK 4 AT TAMBO, BABAK DIST IGACOS. UNDER PR NO. 2022-03-2473***. Delivery of the Goods is required ***Thirty Calendar Days (30CD) upon receipt of the Notice to Proceed***. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belong to citizens of the Philippines.

Interested bidders may obtain further information from *Local Government Unit of the Island Garden City of Samal* and inspect the Bidding Documents at the address given below during ***8:00 A.M. to 5:00 P.M.***

A complete set of Bidding Documents may be acquired by interested Bidders on ***April 28, 2022*** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos only (₱1,000.00).*

The *Local Government Unit of the Island Garden City of Samal* will hold a Pre-Bid Conference on **May 5, 2022 @ 1 o'clock in the afternoon** at **BAC Conference Room, New City Hall Compound Peñaplata, IGaCoS**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at **BAC Conference Room, New City Hall Compound Peñaplata, IGaCoS**, on or before **12 noon of May 17, 2022**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.

Bid opening shall be on **May 17, 2022 @ 1 o'clock in the afternoon** at **BAC Conference Room, New City Hall Compound Peñaplata, IGaCoS**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Local Government Unit of the Island Garden City of Samal* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
